


2012 BOARD SEATS



In 2011, women held 16.1 percent of board seats.

WOMEN'S SHARE OF BOARD LEADERSHIP



Women's representation in nominating/ governance committee chairs continued to keep pace with their share of overall board seats.


Women's representation in all other board leadership positions continued to lag their share of overall board seats.



COMPANIES BY PERCENTAGE OF BOARD SEATS HELD BY WOMEN



In both 2011 and 2012, less than onefifth of companies had 25 percent or more women directors, while onetenth had no women serving on their boards. Less than onefourth of companies had three or more women directors serving together in both 2011 (21.7%) and 2012 (23.1%).


2012 BOARD SEATS BY RACE/ETHNICITY



2012 BOARD SEATS HELD BY WOMEN BY RACE/ETHNICITY



In 2011, women of color's share of board seats held by all women was 18.8 percent. In 2011, women of color's share of board seats held by all women comprised 11.3 percent black women, 4.9 percent Latinas, and 2.5 percent Asian women.

COMPANIES BY NUMBER OF BOARD SEATS HELD BY WOMEN OF COLOR DIRECTORS



In both 2011 and 2012, more than two-thirds of companies had no women of color directors.
